TRAINED AND EQUIPPED TO SUPPORT THEIR MENTEE. WE INCREASED OUR CAPACITY TO
WALK ALONGSIDE MENTEES LONG-TERM BY FURTHER DEVELOPING AN ALUMNI PROGRAM FOR
OUR MENTOR/MENTEE PAIRS WHO HAVE BEEN MATCHED LONGER THAN ONE YEAR AND NO
LONGER REQUIRE INTENSIVE OVERSIGHT. FOUR MATCHES GRADUATED AND SUCCESSFULLY
